It's time to start thinking about the Kate Wolf Festival for 2010. All returning vendors are invited back but it is very important that you get your application and full booth fees to me by March 1st to reserve your space. After that date I will open space for new vendors. All vendors will need a California Resale Number included on the application. Contact the State Board Of Equalization <http://www.boe.ca.gov/info/reg.htm#sales> Santa Rosa Office: (707) 576-2101

I am enclosing your application for a booth at the festival. The price of a 10x20 **food** vending booth is \$1200.00. This includes 5 tickets with the option of buying 3 additional tickets at \$135 each, if purchased before June 1st. Tickets purchased after June 1st will be charged the current rate at the time. Contact me for information if requesting additional space. Checks should be made out to Kate Wolf Memorial Music Festival or KWMMF.

As we worked hard at choosing vendors, returning vendors get a right of first refusal **The deadline for submitting the application and full booth fees is March 1st. After that date I will accept folks from the waiting list.** If you are planning on sharing your booth space with another vendor, please ask me first. I need to know what is being sold at the festival to make sure we do not have too much of anything. Also if sharing a booth we request **one payment** from one vendor.

Food vendors need to comply with all Health Department regulations regarding the sale of food. Please contact the Mendocino County Health Department in Ukiah, 707.463.4466

Food vendors must have liability insurance. Your Certificate of Liability of Insurance must include: Cumulus Presents 7350 Fircrest Ave. Sebastopol, CA 95472, Backroads Productions 7350 Fircrest Ave. Sebastopol, CA 95472 and Black Oak Ranch HWY 101 Laytonville, CA 95454 as additionally insured.
